SUBJECT: 2019 Permissive Tax Exemptions

ATTACHMENT(S): Recommended 2019 Permissive Tax Exemptions

RECOMMENDATION(S):

That the Standing Committee on Finance and Audit recommend that Council approve the 2019 Permissive Tax Exemptions itemized in the attachment to the report dated September 11, 2018 from the Director of Finance titled "2019 Permissive Tax Exemptions".

PURPOSE:

The report provides the Standing Committee on Finance and Audit with an itemized list of the applications that meet the criteria for 2019 Permissive Tax Exemptions and requests that the Committee recommend that Council approve the exemptions.

STRATEGIC PRIORITIES:

Sustainable Finance Guideline 5.5 indicates that Permissive Tax Exemptions are a means for Council to support organizations within the community to further Council's objectives of enhancing quality of life and delivering services economically. There is no obligation on Council's part to grant exemptions.

POLICY/REGULATORY ANALYSIS:

Council approves Permissive Tax Exemptions in accordance with the authority granted through Section 224 of the *Community Charter*.

The Permissive Tax Exemption Policy was used in conjunction with the Permissive Tax Exemption Administrative Procedure to adjudicate the Permissive Tax Exemptions. As per the Policy, the length of the exemptions provided will be granted to the organizations for a period that coincides with the existing Council's term of office, up to a maximum of 4 years. However, the owners of the exempted properties are expected to apply annually and state any changes that have occurred, which are then reviewed by Administration.

FINANCIAL CONSIDERATIONS:

Permissive Tax Exemptions are generally granted for non-profit organizations, places of public worship and private schools, and municipal tenants. The total estimated value for the tax exemptions in this report's recommendations is \$2,052,470 or 1.98% of the tax levy (based on

2018 tax rates and assessment values). The exact amount of these exemptions will not be known until the time that BC Assessment releases the revised property tax roll in 2019.

Non-Profit Organizations

The estimated value of exemptions recommended for non-profit organizations for 2019 is \$1,052,855; the value of new exemptions recommended by Administration is \$87,593. The new non-profit applications are:

1. 00-02798-000 – Association Advocating for Women and Children (AWAC) – 30 low income units for individuals struggling with homelessness due to addictions, mental health and health issues with 24 hour staff to provide assistance and life skills support to the tenants. Completion of the renovations will not be completed until November 15, 2018.
2. 00-00891-000 – Canadian Mental Health – This building is leased from an owner who is not otherwise exempt from taxation under s. 220 of the *Community Charter* and therefore does not meet the subject property guideline to qualify for an exemption.
3. 00-03643-000 – Intersect Youth and Family Services – Leasing Municipal property to provide the delivery of Intersect’s “Switch Program” for local at risk youth.
4. 00-03525-000 - Prince George and District Elizabeth Fry Society – Providing equitable access to support services and programs necessary to women, children and LGBTQ2 experiencing violence/abuse or leaving an abusive situation.
5. 00-02859-000 - Lheidli T’enneh First Nations – The existing building was renovated into a multi-purpose community center. It is also provides a fitness room, community kitchen and a games room. This center will add another value to downtown Prince George to bind together this unique community. Cultural activities will be hosted here throughout the year.
6. 00-00934-000 - Prince George Farmers’ Market Association – Leased from City of Prince George and used to conduct the weekly market. Bringing in local food, goods arts and crafts and providing a major destination site downtown, increasing the vibrancy of downtown and providing economic opportunity for local growers and others to sell their products. Although the PGFMA itself is a non-profit organization, the PGFMA’s 2015 and 2016 permissive tax exemption requests were denied as an exemption was perceived as providing financial assistance to the vendors that use the stalls.

Administration recommends that the Intersect, Prince George Elizabeth Fry Society and Lheidli T’enneh First Nations applications be APPROVED.

Administration recommends that the AWAC, Canadian Mental Health and the PG Farmers’ Market applications be DENIED as they do not meet the requirements for exemption at the time of this report.

Private Schools and Places of Public Worship

Private Schools and Places of Public Worship generally receive statutory tax exemptions. The Permissive Exemption they apply for relates to the hall and the land surrounding the school or place

of worship. The estimated value of exemptions for private schools and places of worship for 2019 is \$479,810.

There are no new applications for private schools and places of public worship.

Municipal Tenants

Municipal Tenants who meet the criteria of the Permissive Tax Exemption program can apply if the property taxes are not already a financial consideration as part of their lease agreement. The estimated value of the exemptions recommended for municipal tenants in 2019 is \$519,805. There is no change in the recommended list of properties for exemption from 2018.

As in prior years, BC Assessment will assess City tenants for commercial areas and those areas will be taxable. The taxable portion, which is unknown at this time, is not reflected in this report. Therefore, the estimated tax assistance for City tenants may be slightly overstated.

There are no new applications for exemption from municipal tenants.

SUMMARY AND CONCLUSION:


The recommended permissive exemption amount for 2019 (\$2,052,470) does not include statutory exemptions provided under Section 220 of the *Community Charter*.
