ELIGIBILITY

The Leisure Access Program (LAP) provides an opportunity for individuals with limited income to participate in recreational activities.

In order to qualify, the applicant(s) must be a permanent resident who lives within the City of Prince George municipal boundaries and meets one of the two categories below:

- Have an annual family income in the previous/current year that is below the Statistics Canada Low Income Guidelines.
- Receive a BC Seniors Supplement that is below the Statistics Canada Low Income Guidelines.

PROCESS

- Ensure your agency is an identified referral agency before applying.
- Verify that the client has met the eligibility requirements.
- Complete the entire application form prior to submitting on behalf of the client.
- Review the Leisure Access Program with the client.

LEISURE ACCESS PROGRAM

- Each client receives 52 complimentary public swimming or skating admissions.
- Once all of the 52 free admissions are used, you are eligible to purchase a 10 visit pass, monthly or annual pass, and receive a 75% discount off the pass.
- Clients are Eligible for a 75% discount off programs (\$50 credit max.) such as swimming lessons and Community Association programs.
- Leisure Access cards can only be used by the person named on the card.
- Passes are good for one year from the date issued, and are non-transferrable. Clients must re-apply on an annual basis.
- Children (12 & under) ride Prince George Transit for free on Saturday and Sunday when accompanied by an adult.
