Discussion commenced and D. Wasnik, Director of Planning and Development, responded to questions of Council.

Applicant:

Ms. Ashley Thandi, Community Planner, and Mr. Tanner Fjellstrom, Professional Engineer, L&M Engineering Ltd., attended Centre Table and provided a PowerPoint presentation in support of the application including information on the subject property, University Heights Neighbourhood Plan, land acquisition/land swap, existing and proposed zoning and Official Community Plan amendments, public consultation, traffic impact study, and servicing brief.

Discussion commenced. D. Wasnik, Director of Planning and Development, and Mr. Fjellstrom responded to questions of Council.

Representations from Members of the Public:

Mr. Andrew Adams, 3286 Maurice Drive, attended Centre Table and spoke in opposition to the application noting concerns regarding the impact of possible land and soil erosion resulting from a clearcut of the subject property and significance of the greenspace area.

Mr. James Steidle (unknown address) attended Centre Table and spoke in opposition to the application noting concerns regarding the proposed 30% reduction of

greenspace the City will own as a result of the proposed land acquisition/land swap, questions regarding costs for road installation, considerations on impacts to wildlife habitat, reforestation, and the lack of mixed use and community space in the subject area.

Ms. Jenn Mathews (unknown address) attended Centre Table and spoke in opposition to the application noting concerns with the cumulative effects of ongoing Official Community Plan and Zoning amendments, land slide and erosion concerns with tree clearing, and the lack of walkability considerations in the proposed development.

Ms. Suzanne Weber (unknown address) attended Centre Table and spoke in opposition to the application noting concern regarding "flat over steep" landslides that occur on potentially unstable slopes caused through the removal of vegetation and destabilizing the escarpment.

Ms. Zoe Meletis (unknown address) attended Centre Table and spoke in opposition to the application noting concerns at the removal of greenspace while not encouraging build to the maximum allowable density of the proposed zone.

Ms. Thandi and Mr. Fjellstrom, L&M Engineering Ltd., returned to Centre Table and responded to questions of Council noting that a geotechnical investigation will be completed at the subdivision stage of the proposal.
