### **VOLUNTEER RESIDENTIAL WATER METER TERMS OF AGREEMENT**

1. I understand that I am volunteering for a water meter to be installed at the address listed above and I am authorizing the installation.
2. I certify that I am the owner of the property listed above.
3. I understand that a plumbing permit shall be applied for and the installed water meter shall be inspected by the City of Prince George Plumbing Inspector in the year of application.
4. I am aware that after the meter is installed, I will be charged volumetrically according to the current Comprehensive Fees and Charges Bylaw.
5. I am aware that after I have a meter installed, I cannot have it removed from my home, nor can I request to return to the flat rate program. I understand that the meter must remain on the water line through all real estate transactions and other property transfers.
6. I am aware that the water meter belongs to the City of Prince George and that I will be liable for any damage, or alterations to the equipment, through the actions or inactions of myself or any other person in my house.
7. I am aware that in signing this agreement, I agree to provide access to the City of Prince George, or to anyone authorized by the City of Prince George for the purposes of reading, maintaining, repairing or replacing the water meter or any associated equipment.
8. I am aware that the City of Prince George will incur the cost of the water meter. The home owner will incur the cost of the plumbing permit, all of the installation of the water meter, all pipe fittings and adapters, and any construction required to repair damage created through the installation of the water meter.
9. I am aware the water meter must be readily accessible, clear of all obstacles and obstructions and cannot be hidden behind permanent non-movable enclosures (this would include things like walls, cabinets, closets, furnaces, hot water tanks, etc).
10. I understand that all information collected by the City of Prince George, as part of the voluntary water metering program, is collected only for the purpose of installing and operating a water meter, for improvements to the Water Conservation Program and for administration of the Water Regulations and Rates bylaw.
11. As per Water Bylaw No. 7479, no person shall tamper with, alter, remove, damage, deface or in any way interfere with the waterworks unless authorized by a permit.
12. I understand by installing a water meter that I will no longer be eligible for the City of Prince George Pre-Authorized Payment Plan.
