Barry Booth, 13405 Wilkins Road, attended Centre Table and spoke in support of more specific objectives for natural environment policies, including clearer methods, working with Professional Biologists, and reporting back on objectives.

Cameron Beck, 3125 19th Avenue, attended Centre Table and spoke in support of having the entirety of the 2011 Official Community Plan Food Security policies incorporated into the bylaw, including indicators of success and progress towards those indicators.

Glenn Froese, 61-32691 Garagaldi Drive, attended Centre Table and spoke to looking forward to having the bylaw completed.

April Ottesen, 270 15th Avenue, attended Centre Table and spoke in support of amending the Official Community Plan to add a Food Charter.

James Steidle, 721 Peardon Road, spoke in opposition to prioritized development, indicated the large increase in municipal infrastructure as a problem.

Jennifer Matthews, 650 Tay Crescent, spoke in support of having a road dedication removed from Ginter's Green area, opposition to the Urban Containment Boundary including UNBC Greenway trails, supports having more indicators of success incorporated, supports amendments for more opportunity for mixed-use and dealing with organic waste.

Danielle Trudeau, 4565 Cascade Avenue, spoke to need for increased housing, a desire for more specified partnerships, and clarity on policy.
