CITY OF PRINCE GEORGE

BYLAW NO. 7970

A Bylaw to authorize the borrowing of funds for the estimated cost of replacing the Cameron Street Bridge.

WHEREAS it is deemed desirable and expedient to undertake this project under general funds;

AND WHEREAS the estimated cost of the various projects, including expenses incidental thereto, is the sum of five million nine hundred and fifty-two thousand dollars (\$5 952 000), which is the amount of debt intended to be created by this Bylaw;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, ENACTS AS FOLLOWS:

- 1. The Council is hereby empowered and authorized to undertake and carry out or cause to be carried out the Cameron Street Bridge, generally in accordance with the plans on file in the municipal office, and to do all things necessary in connections therewith and without limiting the generality of the foregoing:
 - a) To borrow upon the credit of the Municipality a sum not exceeding five million nine hundred and fifty-two thousand dollars (\$5 952 000); and
 - b) To acquire all such real property, easements, rights-of-way, licenses, rights or authorities as may be requisite or desirable for or in connection with the Cameron Street Bridge.
- 2. The maximum term for which debentures may be issued to secure the debt created by this Bylaw is twenty (20) years.
- 3. This Bylaw may be cited for all purposes as "General Loan Authorization Bylaw No. 7970, 2007".
