TAKE NOTICE THAT pursuant to Section 40 and Section 94 of the *Community Charter*, the City of Prince George intends to consider first and second reading of Road Closure Bylaw No. 9460, 2024.

The intent of the Bylaw is to close and exchange a 1.03 ha (hectare) portion of road dedication within 8640 St. Lawrence Avenue and 2800 Vista Ridge Drive, as dedicated on road plans 1065 and 1278.

The location of the road to be closed and exchanged by the City is identified in "gray" on page 2 of this notice.

NOTICE OF PROPOSED PROPERTY DISPOSITION:

FURTHERMORE, TAKE NOTICE THAT pursuant to the provisions of Section 26 and 94 of the *Community Charter*, the City of Prince George intends to exchange to Ridgecrest Development Group Ltd., that portion of road dedicated on Plans 1065 and 1278, District Lot 1605, Cariboo District. In exchange for the closure of this road, the Ridgecrest Development Group Ltd. will dedicate a 0.988 ha (hectare) portion of land for the future expansion of Ospika Boulevard.

The location of the road to be closed and exchanged by the City is identified in "gray" on page 2 of this notice. The location of the property to be dedicated as road for the future expansion of Ospika Boulevard is identified in "gray hatching" on page 2 of this notice.

This notice of property disposition is for the purposes of public disclosure only, not solicitation of an offer.


