The purpose of this application is to vary Section 9.5.6. 1. And Section 9.5.6 2. of the “City of Prince George Zoning Bylaw No. 7850, 2007” for the subject property by increasing the maximum total combined gross floor area of accessory buildings on a site from 90.0 m<sup>2</sup> to 238 m<sup>2</sup> and by increasing the maximum height of accessory development from 7.0 metres to 7.4 metres.


