- To amend the “City of Prince George Zoning Bylaw No. 7850, 2007”, by:
 - rezoning a 2 hectares portion from “AF: Agriculture and Forestry” to “AR2: Rural Residential”; and a 13 hectares portion from “AF: Agriculture and Forestry” to “AR1: Rural Residential”.
 - permitting animal breeding & boarding and animal shelter on the AR2 zoned portion of the property.

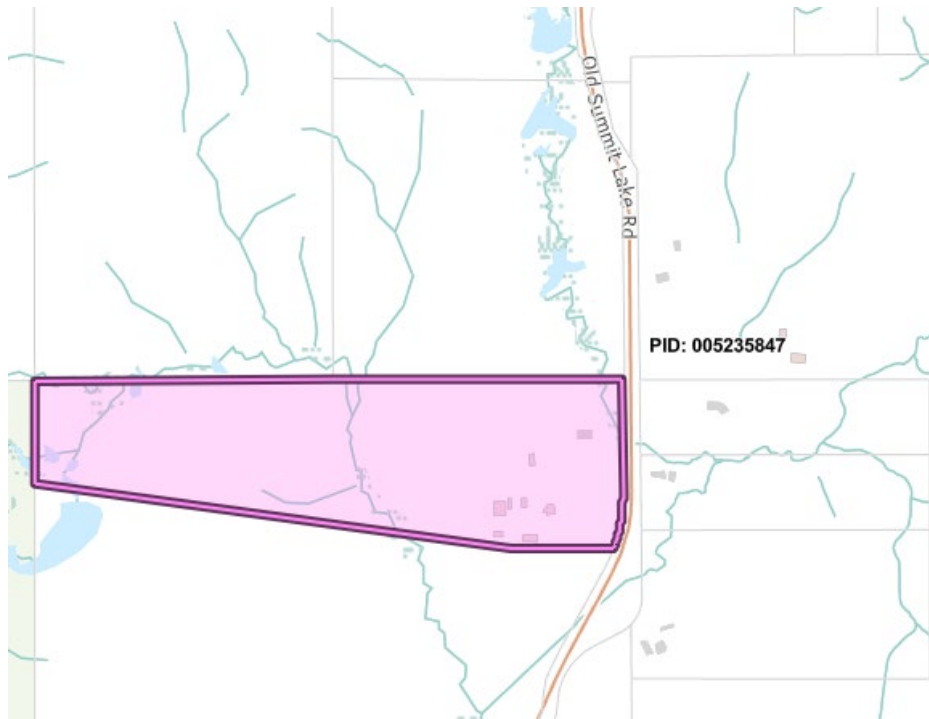
